MMA By-Laws: Article IV Annual Dues: Section 1 - Dues for membership shall be established by the Board of Directors; Section 2 - Any member of the Association who shall be delinquent for a period of 90 days from the time due shall be notified of such delinquency. If payment of dues or an agreement of payment of dues is not made within the next 30 days, the delinquent member shall be dropped from the rolls and thereupon forfeit all rights and privileges of membership. Some Dues Not Deductible: Dues to the Mississippi Manufacturers Association, Inc. may be deductible as a necessary business expense for income tax purposes. However, the portion of your dues used to fund lobbying activities is not deductible. For the current year, that portion is 20%. MMA dues are not deductible as a charitable contribution.
